Article 1: To see if the town will amend the vote taken under Article #2 of the June 20, 2017 Annual Town Meeting, to fix the salary and compensation of all elected offices of the Town as provided for by Chapter 41 Section 108 by increasing the amounts previously voted as proposed in Article #2 in this Warrant, or take any action relative thereto.

Article 2: To see if the Town will vote to amend the vote taken under Article #11 of the June 20, 2017 Annual Town Meeting by reducing or increasing line items in the operating budget for the fiscal year beginning July 1, 2017, as shown in the following table and amending accordingly the amount to be raised and appropriated for such purposes; or take any action relative there to.




